SUBJECT: 2008 Governing Board Member General Election

The statewide general election will be held on Tuesday, Nov. 4, to elect district governing board members to fill terms that will expire on Dec. 5. Enclosed are several documents needed to conduct your district's election¹. (You will receive an additional packet from the County Elections Office.)

Enclosed are two forms—Order of Election and Candidates' Statement—for your board to adopt. Please return both documents to this office by no later than Monday, June 30.

Also enclosed are the following informational items:

1. ***Notification to Consolidate Governing Board Member Elections***
Education Code Section 5340 states the county superintendent of schools shall notify districts that a consolidated election must be held.
2. ***Governing Board Members - Terms Expiring December 2008***
A list, by school district, of board members whose terms expire on the first Friday in December. (Note: the terms for the county board of education members expire on Nov. 28, the last Friday in November.)
3. ***General Election Calendar – Nov. 4, 2008***
A reference on election time lines.
